NOTIFICATION

Dated Dispur the 28<sup>th</sup> July, 2020

**No.FTX.59/2017/288:-** The Governor of Assam is pleased to constitute a Fund, to be called the '**Assam Consumer Welfare Fund**' under the Section 57 of the Assam Goods and Services Tax Act, 2017. The amount shall be credited to the Fund in the saving bank account operated by Commissioner of Taxes, Assam in respect of the following items:-

- any amount payable by a person against an order by the competent authority or Court of Law under provisions of Anti Profiteering activities;
- the amount referred to in sub-section (5) of section 54 of the Assam Goods and Services Tax Act, 2017;
- any income from investment of the amount credited to the Fund; and
- such other monies received by it, in such manner as prescribed in Rule 97 of the Assam Goods and Services Tax Rules, 2017.

For proper utilization of the '**Assam Consumer Welfare Fund**', a Standing Committee is also constituted under sub-rule 4 of Rule 97 of the Assam Goods and Services Tax Rules, 2017 with the following members:-

1.	Additional Chief Secretary / Senior most Secretary, Finance Department	Chairman
2.	Commissioner & Secretary, Finance (Taxation) Department	Vice Chairman
3.	Commissioner of Taxes, Assam	Member
4.	Commissioner & Secretary, Food, Civil Supplies & Consumer Affairs Department	Member Secretary
5.	Commissioner & Secretary, Urban Development Department	Member
6.	Commissioner & Secretary, Guwahati Development Department	Member
7.	Director, Information & Public Relation, Assam	Member

The details of the business of the Committee shall be governed by sub-rule (5) of the rule 97 of the Assam Goods and Services Tax Rules, 2017 and the Committee shall have powers as laid down in sub-rule (6) of the rule 97 of the Assam Goods and Services Tax Rules, 2017. The procedure for disposal of application are prescribed in sub-rule (7) and (8) of the rule 97 of the Assam Goods and Services Tax Rules, 2017.
